## **REACH & CLP regulations - Certificate of conformity for stainless steel and alloy articles produced by UGITECH SA, UGITECH ITALIA & UGITECH TFA**

### **Europe**

Regulation 1907/2006/EC on the Registration, Evaluation, Authorisation and restriction of Chemicals (REACH), amended by Regulation 552/2009/EC, concerning the applicable restrictions listed in appendix XVII, came into force in the European Union on 1 June 2007. All chemical substances used on the European market must be registered with the European Chemicals Agency (ECHA).

Within the scope of REACH, UGITECH is considered as a downstream user of his suppliers and mainly provides articles in stainless steel and alloy.

However, UGITECH remains close to his suppliers to check the status of the substances according to REACH regulation. UGITECH also check the use done by his customers complies with the articles 10 & 37(2).

The continuity of products purchased from UGITECH is therefore ensured in compliance with REACH.

UGITECH Safety Data Sheets comply with REACH Art.31(6).

To the best of our knowledge, our products do not contain any substances :

- subject to restriction above the limit values defined in the entries in Annex XVII and in accordance with the conditions for restrictions laid down;
- SVHC above 0.1% w/w included in the updated [Candidate List of Substances of Very High Concern for authorization](#) of 27/06/2024.

In addition, Ugitech and the products it markets comply with the regulation relating to Annex XIV of substances subject to authorisation.

In addition, our products and packing material don't contain substances included in the actual candidate list submitted to an authorisation according to Art. 33 & 59 (1, 10) with a concentration > 0.1% weight by weight (w/w).

Furthermore, in accordance with Directive 94/62/EC art.11 and (EU) 2018/852 art.1 point 10 amending Directive 94/62/EC and the US Model Toxics in Packaging Legislation (ex. CONEG legislation), UGITECH product packaging complies with the current requirements in terms of heavy metal content.

The sum of the concentration levels of lead, cadmium, mercury and hexavalent chromium present in the packaging or its components does not exceed 100 ppm.

## REACH & CLP regulations - Certificate of conformity for stainless steel and alloy articles produced by UGITECH SA, UGITECH ITALIA & UGITECH TFA

### United Kingdom

Since BREXIT came into force, the UK has adopted its version of REACH called UK REACH (retained Regulation (EC) No 1907/2006). It is applicable since the end of the transition period (31 December 2020) and is backed by the EU REACH regulation.

Annex XIV of UK REACH is similar to Annex XIV of EU REACH as formulated at the end of the transition period.

The UK REACH Article 59-10 article regulation requires to report and inform downstream of the presence of SVHCs above the specified thresholds.

To the best of our knowledge, our products do not contain any SVHC listed in [Annex XIV of UK REACH](#), including the updated [candidate list of substances of very high concern](#).
